- Statement of Health from child's Physician; can use daycare form and have Physician sign, or short statement from Physician office stating child is in good health and can attend daycare

_____ Absent Parent Permit for Emergency Medical/Surgical Care

- This signed authorization is needed in the event of a medical emergency in which BNT's must seek immediate medical care by either transporting your child to the medical facility of your choosing, or utilizing 911 services.

_____ Child Assessment Form

- Tell us a little bit about your child:
 - Health (existing diagnosed physical/mental challenges, medications to be administered by BNT's), Toilet training, Behavior, Eating habits, activities, likes, and dislikes
 - Parents must provide a Physician's Allergen Plan for all medically diagnosed allergens per child. BNT's has this form is available upon request.

- BNT's does not administer prescription medications nor over creams/ointments without Parent written permission
